## **Burning Issues**

There has been some debate on the SLML Facebook page recently about garden bonfires so we have sought advice from the Environment Agency and Wiltshire Council with regards to bonfires. Private households may only burn garden waste that comes from their own property; that is plant tissue, sawdust, shavings and cuttings from untreated wood only. This means that treated wood such as fence panels cannot be burnt on a domestic garden bonfire. All other household waste must be disposed of by the appropriate methods either your bins or direct to a household waste recycling centre.

Bonfires may be deemed a nuisance by exacerbating existing respiratory conditions such as asthma or bronchitis, smoke affecting the visibility on public highways and the threat of fire spreading the neighbouring property. Wiltshire Council has stated that there are no local byelaws regarding bonfires and the hours in which they can be burnt. However, if smoke from a bonfire causes a nuisance they are empowered to take action under the Environmental Protection Act 1990. This applies to household garden bonfires where you are burning garden waste from your own garden.

Ultimately it is all about us all being considerate neighbours but if all else fails the first port of call for nuisance burning is Wiltshire County Council.

If the waste being disposed of is from a commercial organization then permits must be approved and granted by the Environment Agency, full details are available on their website; www.environment-agency.gov.uk/waste
