

SEMINGTON PARISH COUNCIL

Minutes of the meeting held on 20 July 2016 at 8.00pm in the Village Hall

Present.

There were seventy-one members of the public present initially.

1. **Apologies.**

Apologies for non-attendance were received from Cllrs. Scott and Smyth, PCSO Helen Wilson of the Community Policing Team (received 21 July) and from Wiltshire Council Cllr. J Seed.

2. **Declaration of Interests.**

There were no interests declared.

3. **Minutes of the Ordinary Parish Council Meeting held on 15 June 2016.**

4. **Community Policing.**

PCSO Helen Wilson had sent the Clerk a written report the day following the Parish Council meeting and her report is reproduced here in italics:

17/06/2016 – Turnpike Close, Semington - Vehicle stopped ref an expired MOT and breath test carried out. Driver arrested after blowing 69 at the roadside.

Update on the No Entry Watch – to date I have sent out 120 letters advisory letters and 599 vehicles have turned on seeing the volunteers. There will be a PNC Course for 2 of the volunteers hopefully in November, this will enable them to take on all of the admin with regards to No Entry.

The Chairman commented that the representations by members of the public in respect of this planning application during the Public Adjournment had been noted by the Parish Council and that a further Parish Council meeting will be held on 27 July to decide the comments to be sent to Wiltshire Council. He stated that it was clear, following a show of hands during the Public Adjournment, that there was almost unanimous opposition to this application and that the members of the public present objected to the planning application on the following grounds:

- Lack of consultation with the village community.
- The scale of the development.
- The impact on the Kennet & Avon Canal.
- Unsuitable highways access.
- Impact on the village sewerage system.

The Chairman and councillors urged those present to make their opposition to, or support for, this planning application known to Wiltshire Council.

The Chairman stated that Cllr. Scott would be requested to formulate draft comments to be sent to Wiltshire Council on behalf of the Parish Council and that these draft comments will be the subject for discussion at the Parish Council meeting to be held on 27 July.

c. There were no planning applications relating to Semington received after 13 July 2016.

d. There were no other planning matters raised.

He commented that the permanent fixings e.g. shackles for affixing the support ropes for the Christmas tree would be installed soon.
